You are required to report to **BAIL BOND HOTLINE** every **TUESDAY** by phone. You must call the CHECK-IN line at **(877) 461-0132** and follow directions. Upon retaining an attorney you must notify **BAIL BOND HOTLINE of TEXAS** of his/her name, address and telephone number. You may hire an attorney of your own choice. **BAIL BOND HOTLINE of TEXAS** cannot recommend an attorney to you.

You are to notify **BAIL BOND HOTLINE of TEXAS** of any changes to the following: address, telephone number, employer, attorney information and court info-plea bargains, etc.

You are not to leave the county in which you reside without consent from **BAIL BOND HOTLINE of TEXAS**.

The bond premium has been earned by **BAIL BOND HOTLINE of TEXAS** when received and is **NON-REFUNDABLE**. You have paid for a one year premium. INITIAL _____ INITIAL _____ INITIAL _____

The defendant authorizes **BAIL BOND HOTLINE of TEXAS** to immediately surrender all bonds in the event of defendant's arrest and/or warrants on any other charge(s) in any county or state. INITIAL _____ INITIAL _____ INITIAL _____

The Indemnitor can request a release from the bond after submitting in writing and paying the **\$200** administration fee prior to having the arrest warrant issued. INITIAL _____ INITIAL _____ INITIAL _____

Be advised that the Texas State Law for FAILURE TO APPEAR (Jumping Bond) as provided in the Texas Penal Code Section 38.11. Conviction for such an offense is punishable by a jail term of up to 1 year and a \$2,000 fine, or if your offense is a felony, punishment is confinement in a TDC (Texas Department of Corrections) for a period of up to 10 years and fine of \$10,000.

The Indemnitor is **FULLY RESPONSIBLE** for the Bondee court appearances. It is also understood and agreed that the Indemnitor, by signing below is accepting **LIABILITY OF ALL CHARGES** that occur in the event that the Bondee named below does not appear at his/her court date, missed check-in or a missed scheduled payment. Charges include **BOND FORFEITURE** charges, bond fee balances, bounty hunter expenses & **BAIL BOND HOTLINE** administrative charges. INITIAL _____ INITIAL _____ INITIAL _____
